MEMBERSHIP CANCELLATION POLICY

All memberships are purchased with a three month minimum. Memberships may be cancelled or frozen 3 months after your start date. In order to cancel your account, Onyx Wellness must receive a written notice 2 weeks prior to the requested cancellation date. If you would like to freeze your account for 1 to 3 months, you may do so by submitting a written notice to Onyx, 2 weeks prior to your requested freeze date.
